### Minutes Of Meeting

The pre bid meeting for the above work as scheduled, was held on 11.3.2010 at 15.00 hrs under the Chairmanship of Dr N K Mohanty Addl DG and MS Safdarjung Hospital. The pre bid meeting was attended by five prospective bidders and the official of Sports Injury centre, Safdarjung Hospital and HSSC India Ltd.

The list of prospective bidders who attended the pre bid meeting and list of official attended the pre bid meeting is as per annexure 'A' & "B" respectively.

At the onset MS Safdarjung welcomed all the participants to the pre bid meeting. The brief details of the out sourced service for CSSD services was narrated by GM PG III HSCC to the prospective bidders. There after each bidder was requested put forward their query.

.The tender document for the out sourcing of CSSD services is made available at official web site for viewing. One of the bidders informed that the requirement of equipments have been indicated in the bid document however no specification is provided. The bidder requested for the origin of the equipment indented in the bid, whether imported or Indian. It was clarified that equipment shall be foreign make and on further query it was informed that standby equipment to match the uptime requirement can be of Indian origin of specification not lower than specification approved for the this work. However bidder has to obtain approval from the hospital authority for the same.. It was informed to all bidders that specification of approved equipment and BOQ shall be up loaded to web site and on specific request of the bidders present in the meeting the same was agreed to be mailed to them on 11.3.2010 on the email ID provided by them.

The general queries from the prospective bidders were answered and further all the bidders were requested for submission of their all **the queries** in connection with this tender in writing to HSCC ( India) Ltd at their corporate Office situated at E 6( A) , Sector 1 Noida latest by 12.00 hrs on 22.3.2010. Bidders were advised to send the hard copies of their query to HSCC, and for quick response they can email the query on email ID provided by HSCC. However the hard copy version of the bid query shall be final in case of any difference.

The reply to the queries shall be up loaded in the website after approval of competent authority. All bidders were again requested to visit the HSCC India Ltd web site regularly for updates, amendments, corrigendum etc.


